The following Notification shall be published in the next issue of Official Gazette:

NOTIFICATION

In exercise of the powers conferred under section 46 of the Pharmacy Act, 1948 (Central Act 8 of 1948), the Lieutenant Governor hereby makes the following amendment in the Pondicherry Pharmacy Council Rules, 1972, published in Extra Ordinary Gazette of Pondicherry No. 63, dated 13.07.1972 namely:-

1. Short title and commencement - (1) These Rules may be called the Puducherry Pharmacy Council (Amendment) Rules 2021.
2. They shall come into force in the Union Territory of Puducherry from the date of its Notification in the Official Gazette.
2. Amendment of Rule 65 - in the said rules 65, the following shall be substituted:

1.	For the first registration in the register (Registration).	Rs. 500 for B. Pharm Rs. 500 for D. Pharm Rs. 500 for Pharm D (for 1 year)
2.	For every qualification (or) Status subsequently registered (Additional).	Rs. 500
3.	For renewal (Retention).	Rs. 50 for 1- year Rs. 500 for 5 - years
4.	For restoration to the register under Section-37 of the Pharmacy Act, 1948.	Rs. 1,000
5.	For restoration of a name of a person in the register after removal for non-payment of renewal/retention fee in addition to (per year) renewal fee for the year or years during which the name remained removed (Restoration (or) penalty).	Rs. 250



6.	For Eligibility/Good Standing Certificate.	Rs. 2,500
7.	For No Objection Certificate/Migration charge (Payable by outgoing and incoming pharmacist in addition to registration fee).	Rs. 500
8.	For Duplicate Certificate.	Rs. 1,500
9.	For change of name.	Rs. 100
10.	For every certified copy of an entry in the register.	Rs. 200
11.	Application for (each).	Rs. 10
12.	For issue of ID card.	Rs. 100
13.	For late registration (After 1 year) for first registration.	Rs. 500

3. In addition, the stamp duty leviable under the Indian Stamp Act 1899 or any other law for the time being in force relating to the levy of stamp duty shall be levied.
